Terms are Net 15th. All invoices are due in full on or before the 15th day following the month of purchase. A service charge will be assessed on all delinquent invoices. The monthly rate is 1 1/2 % or 18% per annum.

(1). Pending credits from product returns, core credits, exchanges, repurchases or other wise shall not be deemed payment unless and until such credits have been approved by **TEC EQUIPMENT** and are reflected on customers invoice or statement.

(2). Accounts may be placed on hold or on a COD/Cash only basis at our option. In no event shall **TEC EQUIPMENT** be liable for any consequential damages or loss which may result from the exercise of this option. In the event it becomes necessary to bring legal action to enforce the terms of this agreement or to collect any monies now due or which hereafter become due, the customer agrees to pay all costs, disbursements and expenses, including but not limited to, reasonable attorney fees and court costs, including costs of appeal or other review. In the event your account is placed for collection with a Collection Agency, you agree to pay any reasonable collection fee that may be assessed in addition to the amounts owing. Parties hereby agree that the venue for any suit brought to enforce any terms(s) of this agreement shall be in Multnomah County, State of Oregon.

(3).
